## GARDEN JOTTINGS

I've been watching Gardeners' World recently. Monty Don seems to have a penchant for tropical looking gardens and tropical looking plants, ones from warmer countries with showy leaves, the sort you have to put away from cold in winter here, and mostly our springs as ell. I expect much of the vegetation in places in the tropics looks pretty much like our native flora, but some of it does stand out as very different.

Anyone wanting to have their garden looking like somewhere in Malaya has to decide whether to go the whole hog and use genuine tropical plants, and look after them in the winter. The easier way is to choose plants that look tropical, but are really hardy like say the false castor oil plant (fatsia). There are also numerous plants that look tropical and with a little protection will survive an average UK winter.

Walking down a Devon lane round the next bend in the hedge you wouldn't expect to come across a banana tree screaming at you, yellow fruit hanging in the breeze. Yet there are bananas (Musa Basjoo is often mentioned) that will apparently get through an English winter. Their trunks and roots have to be protected with a covering of insulation to keep frost off.

A palm tree in a hedge would be another exotic sight in a Devon lane. Yet again the Chusan palm will usually endure the rigours of an average UK winter. It is a fan palm with clusters of yellow flowers in late spring and a shaggy trunk. In exceptionally favoured coastal locations nowadays with the gradual warming of the climate you may even see pinnate palms with foliage like huge feathers. Large leaves are characteristic of tropical looking vegetation. Paulownia is a hardy Japanese tree with huge leaves and large purple flowers in spring.

There are numerous tropical looking plants with strange large leaves you can use - cannas, arums, arisaemas, rheums, crinums, gunnera, ginger lilies, New Zealand Flax and large ferns, even tree ferns and many more. As for flowers many usual garden flowers are suitable - dahlias, gladioli, red hot poker, phlox. Incarvilleas have spectacular leaves and flowers. Even self-sown English marigolds will give a dramatic spot among large green leaves.

So in this way in the slowly fading light of a sultry sunset you'll be able to relax among exotic crinums and unearthly palm trees in a quasi-tropical paradise.

On VJ Day, there was a small gathering and reading (Philip Watson) in St Mary’s church yard and the bell was rung 75 times (John Thorne) to mark the anniversary.

## **LUPPITT AND THE INTERNATIONAL PEACE GARDEN, CANADA**

You may have noticed that there is a sign saying “Peace Garden” at the top of Church Hill, just the other side of the old telephone exchange. It marks my plot and market garden, and its name is inspired by the International Peace Garden on the Canadian border.

The International Peace Garden nestles in the Turtle Mountain National Park, and is a celebration of peace and a living monument to the ideals of friendship and co-operation between nations. It is acres of uninterrupted prairie, forests and radiant floral gardens, defined by nature not by borders. The idea of a garden on an international border where people could share interests and celebrate friendship, was first conceived in 1928 by Dr Henry J Moore of Islington, Ontario. Plans were submitted to the National Association of gardens and their approval was given for an International Peace Garden. It was decided that the site for this project should be near the geographical centre of North America and the current site, which is located adjacent to the International Border crossing, along the Canada- United States border, between the province of Manitoba in Canada and the state of North Dakota in the United States, was dedicated on July 14<sup>th</sup> 1932. Thousands of individuals from all over the United States and Canada, travelled to witness the ground-breaking and dedication ceremony. There were 2 flagpoles, on one was the Stars and Stripes and on the other the Union Jack to represent the great British commonwealth. Manitoba donated 1451 acres to this project and North Dakota purchased and then donated 888 acres. A landscape architect from Minneapolis was hired and ideas turned into reality and in 1934 the Civil Conservation Corp descended upon the area to perform the physical labour of turning the prairie and forest land into a garden to celebrate peace.

The International Peace Garden was born in the time of the great world depression followed by World War 11, and continued to flourish and shine as a beacon reminding us that friendship between countries was not only possible- but could continue to grow.

The Floral Clock is one of the most iconic features at the International Peace Garden and was donated by Bulova in 1964. It is a duplicate of the original Bulova Floral Clock in Berne,



Switzerland. The diameter of the clock face is 18 feet and includes more than 2000 annual flowers.

There are more than 200 structures within the boundaries of the gardens, with the most notable being the Peace Chapel built in 1968 which is a beautiful stone structure with imported French coloured glass panels, and built from Manitoba limestone. The interior walls hold quotes from many international leaders. There is now a dedicated section to commemorate the 9/11 disaster with actual concrete and twisted steel structures taken from the site. There are unique features such as the Carillion Bells and the Hands of Peace structure. The Carillion was donated by The Central United Church of Brandon, Manitoba, and its 14 bells sound out the Quarter and mark the time of day. These bells were donated to the church in Brandon, Manitoba in 1932 by 4 sons who lived in England, and shipped them to Brandon, in memory of their mother. They were passed on to the International Peace Garden in 1969. The Hands of Peace sculpture is polished stainless steel, stands 6 feet tall and depicts hands releasing a dove. It is set on a pedestal of white granite in a fountain surrounded by shooting sprays of water in dedication to the continuation of the peaceful border the United States and Canada have shared for over 200 years. As you stand in front of this sculpture and look to the West, you have 1 mile of floral gardens, water features and amazing structures stretched out ahead of you. If you look at your feet, you can stand with 1 foot in the United States and 1 foot in Canada.

I have been fortunate enough to have visited the International Peace Garden many times, taken family and friends there and spent many happy hours there with Barbara and family, so when we started the market garden in the field next to the old telephone exchange at the top of church hill in Luppitt and looked down over the valley at that fantastic view, and enjoyed the peace and quiet our thoughts went back to Canada. We don't quite have the same acreage as the International Peace Garden BUT we hope that, as the celebration of peace and co-operation continues on the border of Canada and the United States, it will also continue here in Luppitt and you will come to our Peace Garden, enjoy the wonderful view and taste some of our very fresh produce.

## THE RECTOR'S LETTER

We are now into our sixth month restricted by Covid19 and are all only too aware of the affect that it has had upon us, our families and communities. We have become quite adept at mitigating the risks to ourselves and at protecting others. The bad news that we all know is that this is not over yet and with some foreboding we are all only too aware that the infection levels are rising elsewhere – the end is not in sight.

The latest challenges that have emerged are those for our young people – we all know someone who would have taken exams and has been given results based on a computer algorithm. We also all probably know someone who was furloughed months ago and has now heard that they are likely to be made redundant.

This is a time when our communities are more important than ever – a comparison with the need for community as in the World Wars is not an overstatement. We need to continue the wonderful loving and supporting involvement of the last six months but at the moment perhaps in a slightly different way. The long term stress has been very wearing and has affected many peoples mood and in some inducing a real depression. The need to love our neighbour has never been more important.

I have found it very warming to be meeting people again. Our churches are all now open for private prayer and we have started having Sunday services in all of the churches though not all of them have a service every Sunday. Of course our services are not the same as before – we have to observe social distancing, we have hand sanitisers by the doors, we are not allowed to sing (though I have heard this morning that this might be relaxed), and we sanitise the church buildings by closing them for 72 hours twice a week. All of our regular church goers are saying how wonderful it is to see people, their parish family, to share a smile even if not a shake of the hand or a hug.

The Christian faith is a faith of relationship and our communities are places of relationship and more than ever we need to be in relationship with each other as autumn and then winter approach. We are going to have to work out how to celebrate the harvest, such an important time in our villages and for our farmers, how we commemorate the Armistice on 11<sup>th</sup> November and, looking further away, how we celebrate Christmas. We remain in this together and loving our neighbour, as Jesus taught us, is all important.

## **Receive apologies for absence**

Apologies were received from Cllrs Tom Nancarrow (Vice-Chairman), Beth Hooper, Paul Prettejohn, Colin Brown (EDDC)

## **Minutes of previous meeting**

The Minutes of the meeting held on Tuesday, 2 June 2020, were unanimously agreed and signed as a correct record of that meeting (proposed by Cllr Ryder and seconded by Cllr Turner).

## **Declaration of Interest**

There were no declarations of interest.

## **PLANNING**

### **Applications (for comment, support or objection)**

**20/1088/FUL – Old Spurtham Farm New Road, Upottery – erection of hay storage barn**

The Parish Council has no objection to this planning application.

**20/0947/FUL – Mohuns Ottery, Luppitt, Honiton, EX14 4TS – amendments for proposed private in-ground swimming pool and plant/pool room**

The Parish Council has no comments to make on the amendments.

**Decisions** No decisions to report.

**Shaugh** Nothing to report.

**Neighbourhood Plan:** Roger Hicks has sent an update on progress. As a result of comments received from EDDC and AONB, Roger is working on amendments to the draft plan which he hopes will be completed shortly. He feels that the comments have been positive. Cllr Turner has been working on rebuilding the Neighbourhood Plan website. She has put a digital version of the Luppitt Packet on the website. It is intended that eventually the Neighbourhood Plan website will become more community based. Cllrs Turner, Ryder and the clerk will liaise.

## **HIGHWAYS AND TRAFFIC**

### **Meeting with Neighbourhood Highways Officer on future highway maintenance – Doing What Matters – and resulting actions**

Cllrs Thorne, Pulman and the clerk had a helpful meeting with Phil Morgan, the Neighbourhood Highways Officer, on 24 June. The main thoroughfares through the parish were identified and roads needing repair and drainage issues were prioritised. The NHO will work through the problem areas as his budget allows. He recognises the road maintenance work carried out by the Parish Council and will do his best to complement that work where possible. The Parish Council can apply under the Road Warden Scheme for materials and tools to use for minor road repairs.

Cllr Chubb advised that Highways now has new equipment to repair potholes and resurface roads.

## **Parish Maintenance**

### **Tree Maintenance –**

- **Ash bush by The Linhay** – Cllr Thorne has spoken to the landowner who will investigate.

- **Dead ash tree in the hedge of Chescroft field** – Cllr Thorne is meeting up with the landowner.
  - **Dead ash tree in the hedge near the play area at Millrise** – Cllr Pulman will investigate.
- Mill Lane** - There is an issue where grating by The Mill blocks up. Cllrs Thorne, Tucker and Pulman to investigate and discuss at next meeting.

## **FOOTPATHS AND BRIDLEWAYS**

**Footpath 3** - Carried forward to the next meeting.

**Footpath opposite Church gate** – new waymarker needed. Clerk to check with Cllr Nancarrow for footpath number and will then report to Ros Davies, Parish Paths Liaison Officer at Devon County Council.

## **ENVIRONMENT/COMMUNITY FACILITIES**

### **Community Policing Report**

No report received and the lack of contact with the police was discussed. Cllr Key said that additional police officers are being recruited so, hopefully, there may be more contact in future. Luppitt does have a very low crime rate but the Parish Council feels it is reassuring to have some sort of ongoing contact.

### **Luppitt Packet**

Cllr Thorne had received a letter from the editors and treasurer of the Luppitt Packet expressing their concern that the May Parish Council Minutes gave the impression that the Parish Council is responsible for the publication of the Luppitt Packet, whereas the decision to print and publish is entirely at the discretion of the editors. The Parish Council regretted the misunderstanding. At the start of Lockdown, the editors had indicated that the distribution of the magazine would not be possible because the majority of the distribution team were either self-isolating or shielding and the editors would not have wanted any of the distributors to face unnecessary risks. Cllrs Ryder and Turner had spoken to the editors about producing a digital version and the discussion at the May meeting had been mainly concerned with that aspect. In those circumstances and at that time, a digital version seemed a sensible solution but the Parish Council was keen that this should be a temporary measure only. As things progressed, the editors took the decision to have the April issue printed and posted to residents and the Parish Council was only too willing to help out and pay half the cost of the postage. Cllr Thorne will reply to the letter and make clear that the Parish Council fully understands that the responsibility for the Luppitt Packet rests with the editors and had no wish to imply otherwise or interfere in any way other than to help out.

### **Locality Budget**

Cllr Chubb advised that he has some money available for community projects.

## **FINANCE AND ADMINISTRATION**

### **Internal Audit**

Matters raised by the internal auditor have been, or are being, dealt with by the clerk.

### **External Audit**

The clerk confirmed that the Notice of Public Rights has been displayed on the Village Hall noticeboard and posted on the website. The clerk confirmed that the Annual Governance and Accountability Return (AGAR) and associated papers have been sent to the external auditor.

### **NALC advice on virtual meetings for Parish Councils**

NALC advice is that virtual meeting should continue for the foreseeable future and possibly until May 2021.

**Defibrillator (clerk)** - The clerk has been checking the two defibrillators weekly since they were installed. It was felt that it may be possible that this could be done by local residents and Cllrs Thorne and Tucker undertook to follow up.

### **Correspondence**

There was no correspondence.

### **CHAIRMAN'S DISCRETION**

- The opening of the Village Hall as Lockdown eases was discussed.
- Cllr Chubb undertook to send details of BT's Universal Service Obligation for Broadband.

### **Minutes of previous meeting**

The Minutes of the meeting held on Tuesday, 7 July 2020, were unanimously agreed and signed\* as a correct record of that meeting (proposed by Cllr Tucker and seconded by Cllr Ryder) with the following amendment to the wording of Minute 3.2.2 under Parish Maintenance – delete the words 'There is an issue where grating by The Mill blocks up' and replace with 'The resident of The Mill diverts water from The Mill easement back onto the road'.

### **Declaration of Interest**

There were no declarations of interest.

### **PLANNING**

#### **Applications (for comment, support or objection)**

No applications received.

### **Decisions**

**20/1063/FUL – Snooks Farm, Luppitt, EX14 4SB – erection of solar panels array**

There was a discussion about the planning approval that has been given. The Parish Council had commented originally that it would support any decision taken by the AONB, but the AONB had not been consulted because the officer's report stated that Luppitt was not in an AONB designated area. The clerk will write to EDDC Planning to express concern about the inaccuracies contained within the report. Cllr Ryder proposed that the clerk should contact the AONB planning officer and find out what comments the AONB would have made had they been consulted. This would help with any future planning applications for solar panels. The proposal was seconded by Cllr Pulman with all in agreement.

**Neighbourhood Plan** - Roger Hicks is continuing to work on amendments to the draft plan. Roger has suggested testing the draft plan against theoretical planning applications. Cllr Ryder will liaise with Roger and Cllr Turner.

### **Housing Needs Survey**



The clerk will respond to Janice Alexander's email to say that the Parish Council has no immediate plans to carry out a housing needs survey.

## **HIGHWAYS AND TRAFFIC**

**Parish Highways programme** - update on Items to Report:

- Loose kerbstones at Millrise – Cllr Key will continue to follow up as work is unsatisfactory.
- Several potholes at the lower part of School Lane towards Ringborough Cross and severe edge of road deterioration from Maple Cross to Pound Farm - discussed with and reported to Neighbourhood Highways Officer.
- Potholes between Higher Wick and Fortfield houses – repair still awaited.
- Urgent attention needed towards Pound from Maple Cross by bungalow on right-hand side where the road has subsided – Neighbourhood Highways Officer has cleared the culvert and has asked Structures to check the road structure.
- Pothole near Little Shelvin – clerk to report although it was felt it would not meet the repair criteria.

## **Parish Maintenance**

### **Tree Maintenance –**

- **Ash bush by The Linhay** – Cllr Thorne has spoken to the landowner.
- **Dead ash tree in the hedge of Chescroft field** – nothing to report.
- **Dead ash tree in the hedge near the play area at Millrise** – nothing to report.

**The Mill** - Cllrs Thorne, Tucker and Pulman will speak to the resident before the next meeting.

- Footpath 26 new post and waymarker needed at start of footpath 26 just below Snooks Farm. A new post and waymarker are also needed about 200m up from Snooks as the path meets the road, pointing up the hill over Hartridge.
- Footpath 24 to Rawridge – a new 3" stake is required for the handrail on the small footbridge.

Although it is annoying, the Parish Council has no jurisdiction over this sort of activity and the only steps to take are for residents to report any incidents to the relevant authorities. The Parish Council will monitor any domestication of this field in the future.
