Minutes for a meeting of Luppitt Parish Council held in the Village Hall at 8pm on Tuesday 5th February 2008.

In making decisions the Parish Council recognise their statutory duties provided for in Section 11A(2) of the National Parks and Access to the Countryside Act 1949 (National Parks) and Section 85 of the Countryside and Rights of Way Act 2000 (AONBs) that in exercising or performing any functions in relation to, or so as to affect, land, they shall have regard to their purposes (ie conserve and enhance their natural beauty, wildlife and cultural heritage and to promote opportunities for the understanding and enjoyment of their special qualities by the public).

1. **Decisions** (for information)

07/2227/LBC Greenway Manor – permission granted for damp proofing, conservation and repair to guest annex and gatehouse, retention of minor alterations to house and complex.

2. **07/3363/COU Primrose Farm** – conversion of agricultural storage building to holiday unit

Recommendation: REFUSAL recommendation made prior to meeting by committee due to EDDC time restrictions recommendation ratified by meeting. After viewing the property at a site meeting of five Parish Councilors on Monday 14th January 2008, it was unanimously agreed, that the parish council recommend refusal of this application on the following

grounds:unsuitable road access - the proposed building for conversion is a modern, single skin concrete block farm building, recently rendered on its external face, which has no architectural merit whatsoever.

- 07/3457/FUL Penn Farm replacement workshop garage and machinery store. Recommendation: APPROVAL recommendation made prior to meeting by committee due to EDDC time restrictions recommendation ratified by meeting.
- 07/3492/LBC Pilgrims Cottage re-thatch rear elevation in water reed including new ridge internal alterations to include relocation of staircase. Recommendation: APPROVAL

 - 2. Smeatharpe Stadium Cllr Key informed the meeting that EDDC and MDDC are organising a joint meeting with the owners of land at Smeatharpe regarding application for Certificate of Lawful Use and permitted uses. There is much concern locally that now the area is in divided ownership that each landowner may decide to apply for separate CLU for 17 days each.

3. HIGHWAYS AND TRAFFIC

 DCC road closure order – Langford Road – A30 Junction to Crook Cross will be closed 18th – 22nd February

2008 for highway works. Clerk to tell Highways that this needs to extend to Limers Cross.

2. Thanks to the persistence of a parishioner and the cooperation of Highways a water hazard in the lane between

Ford Cottages and Whitehall Farm has been resolved. It is personal interest like this from the public that helps the parish council immensely in sorting local issues. Clerk to ask Mr Barlow for an invoice for £50 for materials used, as the parish council would be pleased to contribute to this project as an act of goodwill.

3.3 Roads – potholes double bends between Mountstephen and Luppitt Cross, at Luppitt Cross on the main road, recently filled potholes at Ringborough Cross, Fairview have now reappeared, Woodhayes to Shaugh Farm, road edge on Gulley lane outside Coombeshead (ditches are blocked here and overrunning the road edges). Banger Stadium to Ford there is subsidence and general deterioration – many potholes deeper than 4".

4 FOOTPATHS AND BRIDLEWAYS

- 4.1 DCC temporary prohibition of pedestrians order 20th December 2007 20th June 2008 Bridge between Combe Raleigh Footpath 10 and Luppitt footpath 38, Combe Raleigh, Luppitt. Bridge unsafe and closed on health and safety grounds (no alternative route).
 - 2. P3 forms for completion Mr Brake has completed the return and the full balance of funds in the P3 account

have been spent or allocated. AGREED.

4.3 The revised definitive map showing the correct position of Footpath 54 has now been received thanks to Cllr Sparks proving the path was officially moved in 1985.

- 6.1 **Community policing report** between 04/12/07 04/02/08 there were six crimes as follows: a Non Crime Child Protection Concerns for a resident at a care home, a Theft quad bike stolen from open barn BUT later recovered unattended in Taunton, Criminal Damage to Motor Vehicle Vehicle parked at Millrise Mirror broken off, Burglary Dwelling Entry to attached garage through insecure window and attempt to enter house via connecting door.No entry to main house nothing stolen. Theft od three copper cylinders (kept for scrap) stolen in rural field and one Assault two juveniles who reside in care home had a fight leading to injuries.

Mr Pulman and Mr Tucker to release envelopes and decide on amalgamating contents. This has now been taken over by the Village Hall.
- 3. Signatories for hall accounts and accounting for Walden Bequest Fund to be clarified. A letter has been located dates April 1996 and sent to the Audit Commission informing them that as of that date the money held in the Walden Bequest Fund would be accounted for by the Village Hall Committee. Reply from hall awaited at the next meeting. 7.5 Precept for agreement 2008/9 budget attached £4000 agreed which will include a further £500 on top of clerks proposed budget for general parish maintenance.
