3 HIGHWAYS AND TRAFFIC

- 3.1 Map of highways issues in the parish Chairman has contacted Greenway and they have committed to mend the pipe that is discharging onto the road. Mr Tucker was thanked for the work that he is doing around the parish, this is now about half way through the agreed programme and more will be done. The work is making a significant difference to the parish. Cllr Clapp mentioned there are pipes across the road at Taunton Hill, Sharcombe to the top of Hartridge also two additional lanes under School lane on bridleway 12 these both need the outlets clearing. It was agreed that these should be cleared as part of the parish maintenance programme
- 3.2 Potholes for Highways to fill there are two very large potholes on the road from Beacon to Barn both about 8" deep. School Lane has a storm damaged road edge below Clouds this is a serious hole at about 18" deep and 18" wide, creating a dangerous drop. Maple Cross to Halsdon there is a pothole th size of a wheelbarrow. At the bridge between Coal Hill and Messhayes tther is a large piece of road edge missing, two stab markers have been put in to mark the hole, but one has already gone in. Potholes Dolish to Tapsters (just below Dolish Farm) are still needing attention. Request a visit to inspect the side of the lane at Coombehead Farm to Luppitt Common the other way to Fairview Farm/Ringborough Cross as the road is being undercut and approximately 12" of road have been lost in recent storm damage (recent tarmac has been washed away). Request lengthsman to clear the overgrowth at Coal Hill Ford foot bridge.
- 3.3 Clerk to ask police to back a submission to DCC for chevrons on the double bends.
- 3.4 DCC Road closure for Balfour Beatty (South West Water) C352 lane past Littletown Farm 9th 11th March 2009. Closure from junction with road past Millrise to junction with road from Mattys Cross to Shelves Farm. Alternative route via Dolish Farm, Hillend Farm, Hartridge Common Shelves Cross and vice versa. Clerk to check why the road is to close when the main is in a field, and that they should contact to land owner before they gain access.

3.5 Wick Bridge is scheduled for repair this year, footpath 1 from the Pub to Corner Cottage, shingle is to be laid (parish council will recycle the shingle that has been taken out of the ditch at Greenlands). Annual returns are submitted. It was discussed that a meeting will be organised to log the memories of parishioners regards parish footpath claims.
