Cllr Hooper declared an interest and left the room while the following two applications were discussed and a vote taken.

- 2.3.1 10/1465/FUL Higher Wick Farm construction of replacement cubicle shed.
- 2.3.2 10/1464/FUL Higher Wick Farm construction of hay and straw shed.

Comments: The parish council support both these applications on the condition that the public highway outside the farm is kept in a clean and reasonable condition for pedestrians and other road users (including school children walking to the school bus) throughout the year. We would request that there should be a condition placed on the grant of any permission that a sustainable drainage system must be approved prior to commencement of works and installed under/along the edge of the highway to achieve this and prevent surface runoff pooling on the road and against the side of the proposed new building.

3 HIGHWAYS AND TRAFFIC

- 3.1 Parish Highways programme There is a meeting for parish councillors on Friday 20th August 2010 with Highways to discuss all the highways issues in the parish, it can then be ascertained what they can do and what the parish can do to in terms of self help.
- 3.2 Cllr Key is to check what additional visibility work is to be done with the Windgate hill junction to Woodhayes. Cllr Brake said the applicant had suggested there will be further improvements when a further application is submitted.
- The road past the Church will be closed shortly for the lay-by to be tarmaced, it is hoped surface dressing might also be done at this time. There is a tyre-catching pothole between Mountstephens and the Double Bends clerk to report. Mrs Fry has also requested that the recently cut visibility splay across the hairpin bend by Hillend is cut tighter and a larger area cut to enable proper visibility.
